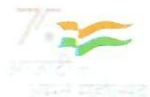

At the outset, the Managing Director of NHB, as Chairman of the PAC, extended a warm welcome to all members of the Project Appraisal Committee (PAC), as well as officials from the Ministry of Agriculture and NHB. He addressed the participants and provided a brief overview of the evaluation criteria and timelines laid out in the scheme guidelines, which form the basis for evaluating the proposals. He further emphasized that the evaluation of concept notes received under High-Value Multi-Commodity Clusters and Peri-Urban Vegetable Clusters is being carried out strictly in accordance with the Scheme Guidelines.

Further, Shri Pawan Kumar, DD, NHB and representative of the PMU, presented the evaluation process. He appraised the committee of the responsiveness checks undertaken to assess the completeness and compliance of each proposal with the prescribed guidelines. Each concept note was presented individually through a detailed presentation.

1. M/s Avyansh Cacao Industries Private Limited (Consortium of Private Limited Companies and Partnership Firm), Project Code 28ACDP000155

The applicant M/s Avyansh Cacao Industries Private Limited is a Private Limited Company. The applicant has applied in a consortium with M/s The Box Logistics, M/s Majoris Trade and Exports Private Limited and M/s Velumuri Infra Private Limited. The applicant has experience in contract manufacturing of chocolates and value-added cocoa products. They are also exporting the cocoa products to USA and European markets. For FY 2023-24 the consortium's turnover is INR 4387.67 Lakhs and networth is INR 984.72 Lakhs. The applicant has submitted a concept note to set up a Multi Commodity High Value Cluster with Cocoa as focus crop in Andhra Pradesh.

The committee reviewed the concept note and observed that the applicant meets all legal and financial criteria, including equity, net worth and a clean financial declaration. The proposal was technically evaluated and scored 36 out of 50. The PAC decided that the proposal may be shortlisted for submission of DPR / business case with the inclusion of additional horticultural crops and financial documents of the consortium members.

2. M/s Fanidhar Mega Food Park Private Limited (Consortium of Private Limited Companies) - Project Code, 24ACDP000153

The applicant M/s Fanidhar Mega Food Park is a private limited company and has the application in consortium with M/s Fanidhar Agrotech Private Limited, M/s Fanidhar Enterprises Private Limited and M/s Saptarishi Agro Industries Limited. The group is a diversified agri-business conglomerate engaged in food processing, warehousing, logistics, and integrated agri-value chains. The applicant operates its own processing units. For FY 2023-24 the applicant's turnover is INR 25826.46 Lakhs and networth is INR 11644.56 Lakhs. The applicant has submitted a concept note to set up a Multi Commodity High Value Cluster with Potato as focus crop in Gujarat.

The committee reviewed the concept note and observed that the applicant meets all legal and financial criteria, including equity, net worth and provided a clean financial declaration. The proposal was technically evaluated and scored 37 out of 50. The PAC decided that the proposal may be shortlisted for

submission of DPR / business case and also suggested that the interventions for additional horticulture crops may be included in the business case / DPR stage.

3. M/s Wholesome Foods (Partnership Firm) - Project Code, 24ACDP000147

The applicant M/s Wholesome Foods is a partnership firm. The applicant is marketing under the brand name Home Roots; the firm offers a diverse portfolio of products including frozen vegetables & fruits along with a wide range of frozen-to-ready-cook specialties. For FY 2023-24 the applicant's turnover is INR 2264.85 Lakhs and networth is INR 1412.36 Lakhs. The applicant has submitted a concept note to set up a Multi Commodity High Value Cluster with Okra / LadyFinger as focus crop in Gujarat.

The committee reviewed the concept note and observed that the applicant meets all legal and financial criteria, including equity net worth and a clean financial declaration. The proposal was technically evaluated and scored 36.5 out of 50. The PAC decided that the proposal may be shortlisted for submission of DPR / business case.

4. M/s Chheda Agro Food Park Private Limited (Private Limited Company) - Project Code, 27ACDP000146

The applicant M/s Chheda Agro Food Park Private Limited is a Private Limited Company. The applicant has experience in manufacturing a diverse product range from 200 SKUs under 15 different product categories in the salted snack segment. These include Potato chips, Banana Chips, Chivdas, Mixtures, Sev, Bhels, Novelty snacks, Boondi, Dal, Instant snacks, Popup, Ckikki, Son Papdi, South Indian snacks and roasted chana. For FY 2024-25 the applicant's turnover is INR 8200.94 Lakhs and networth is INR 3079.81 Lakhs. The applicant has submitted a concept note to set up a Multi Commodity High Value Cluster with banana as focus crop in Maharashtra.

The committee reviewed the concept note and observed that the applicant meets all legal and financial criteria, including equity, net worth and provided a clean financial declaration. The proposal was technically evaluated and scored 35 out of 50. The PAC decided that the proposal may be shortlisted for submission of DPR / business case and also suggested that the other horticulture crops along with suitability may be included in DPR in coordination of State Department of Horticulture.

5. M/s Lalsai Global Limited (Public Limited Company) - Project Code, 24ACDP000117

The applicant M/s Lalsai Global Limited is a Public Limited Company. The applicant is a globally certified food exporter, holding international certifications such as FSSAI, HACCP, BRC, USFDA, HALAL, KOSHER, and SEDEX. The applicant is currently exporting to the markets in USA, UK, EU, Russia, and Southeast Asia. The applicant has experience in dehydration of onions, garlic, carrots, cabbage, and other seasonal produce. For FY 2024-25 the applicant's turnover is INR 9514.29 Lakhs and networth is INR 662.32 Lakhs. The applicant has submitted a concept note to set up a Multi Commodity High Value Cluster with onion as focus crop in Gujarat.

The committee reviewed the concept note and observed that the applicant meets all legal and financial criteria, including equity, net worth and a clean financial declaration. The proposal was technically evaluated and scored 37 out of 50. The PAC decided that the proposal may be shortlisted for submission of DPR / business case with the inclusion of other horticultural crops and also suggested that It was also discussed in the meeting that planting material for white onions need to be addressed.

6. M/s NextOn Foods Private Limited (Private Limited Company) - Project Code, 23ACDP000116

The applicant M/s NextOn Foods Private Limited is a Private Limited Company. The applicant has experience in fresh produce, frozen products, and hydroponics. They have wide range of "Kryo Recipes"

such as Green Peas Masala, Mixed Vegetables, and Carrot Poriyal. For FY 2024-25 the applicant's turnover is INR 6005.12 Lakhs and networth is INR 690.72 Lakhs. The applicant has submitted a concept note to set up a Multi Commodity High Value Cluster with papaya as focus crop in Madhya Pradesh.

The committee reviewed the concept note and observed that the applicant meets all legal and financial criteria, including equity, net worth, and a clean financial declaration. The proposal was technically evaluated and scored 34.5 out of 50. The PAC decided that the proposal may be shortlisted for submission of DPR / business case with the inclusion of other suitable horticultural crops.

7. M/s Sunshine Vegetables Private Limited (Private Limited Company) - Project Code, 09ACDP000114

The applicant M/s Sunshine Vegetables Private Limited is a Private Limited Company. The applicant is India's largest producer of premium Nantes/English and Red Hybrid carrots. The applicant has experience in large-scale carrot production and allied crops, along with its processing. For FY 2023-24 the applicant's turnover is INR 4305.97 Lakhs and networth is INR 3822.83 Lakhs. The applicant has submitted a concept note to set up a Multi Commodity High Value Cluster with carrot as focus crop in Uttar Pradesh.

The committee reviewed the concept note and observed that the applicant meets all legal and financial criteria, including equity net worth and a clean financial declaration. The proposal was technically evaluated and scored 32.5 out of 50. The PAC decided that the proposal may be shortlisted for submission of DPR / business case.

8. M/s Infra Cool Private Limited (Consortium of Private Limited Companies and Cooperative Society) - Project Code, 09ACDP000124

The applicant M/s Infra Cool Private Limited is a Private Limited Company and has the application in consortium with M/s National Federation of Farmers' Procurement, Processing and Retailing Cooperatives of India Ltd, M/s Agribid Private Limited and M/s Luminis Tech. The applicant has experience in Construction of CA Stores, Frozen Stores, IQF Stores. For FY 2024-25 the applicant's turnover is INR 4602.52 Lakhs and networth is INR 633.79 Lakhs. The applicant has submitted a concept note to set up a Multi Commodity High Value Cluster with tomato as focus crop in Uttar Pradesh.

The committee reviewed the concept note and observed that the applicant meets all legal and financial criteria, including equity net worth and a clean financial declaration. The proposal was technically evaluated and scored 35.5 out of 50. The PAC decided that the proposal may be shortlisted for submission of DPR. It was also noted that the DPR / business case shall include other horticultural crops (fruits) as per the CDP scheme guidelines.

9. M/s Green Agrevolution Private Limited (Private Limited Company) - Project Code, 27ACDP000144

The applicant M/s Green Agrevolution Private Limited is a Private Limited Company. The applicant is a leading agritech platform that integrates end-to-end agricultural services—from input distribution and AI-driven advisory to credit and market linkage. They operates across 150+ districts via a grassroots network of 14,000+ DeHaat Centers, serving over 130,000+ villages nationwide. For FY 2023-24 the applicant's turnover is INR 2,64,759 Lakhs and networth is INR 75,590 Lakhs. The applicant has submitted a concept note to set up a Multi Commodity High Value Cluster with Grapes as focus crop in Maharashtra.

The committee reviewed the concept note and observed that the applicant meets all legal and financial criteria, including equity, net worth and a clean financial declaration. The proposal was technically evaluated and scored 43 out of 50. The PAC decided that the proposal may be shortlisted for submission of DPR / business case.



10. M/s DhariwalCorp Limited (Public Limited Company) - Project Code, 08ACDP000143

The applicant M/s DhariwalCorp Limited is a Public Limited Company. The applicant has experience in the spices processing, distribution and export category. For FY 2024-25 the applicant's turnover is INR 23646 Lakhs and networth is INR 3461.85 Lakhs. The applicant has submitted a concept note to set up a Multi Commodity High Value Cluster with cumin as focus crop in Rajasthan.

The committee reviewed the concept note and observed that the applicant meets all legal and financial criteria, including equity, net worth, and a clean financial declaration. The proposal was technically evaluated and scored 38 out of 50. The PAC decided that the proposal may be shortlisted for submission of DPR / business case.

11. M/s Green Agrevolution Private Limited (Private Limited Company) - Project Code, 27ACDP000138

The applicant M/s Green Agrevolution Private Limited is a Private Limited Company. The applicant also mentioned in their concept note that they are the leading agritech platform that integrates end-to-end agricultural services—from input distribution and AI-driven advisory to credit and market linkage. They operate across 150+ districts via a grassroots network of 14,000+ DeHaat Centers, serving over 130,000+ villages nationwide. For FY 2023-24 the applicant's turnover is INR 2,64,759 Lakhs and networth is INR 75,590 Lakhs. The applicant has submitted a concept note to set up a Multi Commodity High Value Cluster with Banana as focus crop in Maharashtra.

The committee reviewed the concept note and observed that the applicant meets all legal and financial criteria, including equity, net worth and a clean financial declaration. The proposal was technically evaluated and scored 32.5 out of 50. The PAC decided that the proposal may be shortlisted for submission of DPR / business case.

12. M/s Social Action for Tribal and Backward Classes (Society) - Project Code, 14ACDP000137

The applicant M/s Social Action for Tribal and Backward Classes is a society. The applicant has experience in agricultural development, horticulture, handloom and handicrafts in Manipur. For FY 2024-25 the applicant's turnover is INR 4,051 Lakhs and networth is INR 5,873 Lakhs. The applicant has submitted a concept note to set up a Multi Commodity High Value Cluster with Kiwi as focus crop in Manipur.

The committee reviewed the concept note and observed that the applicant meets all legal and financial criteria, including equity, net worth and a clean financial declaration. The proposal was technically evaluated and scored 37.5 out of 50. The PAC decided that the proposal may be shortlisted for submission of DPR / business case.

13. M/s Agriplast Tech India Private Limited (Consortium of Private Limited Companies) - Project Code, 27ACDP000125

The applicant M/s Agriplast Tech India Private Limited is a Private Limited Company and has the application in consortium with M/s Jackfruitking Agro Producer Company Limited. The applicant also provide services for protected cultivation and hi-tech agricultural solutions. For FY 2023-24 the applicant's turnover is INR 13201 Lakhs and networth is INR 3223.84 Lakhs. The applicant has submitted a concept note to set up a Multi Commodity High Value Cluster with jackfruit as focus crop in Maharashtra.

The committee reviewed the concept note and observed that the applicant meets all legal and financial

criteria, including equity, net worth, and a clean financial declaration. The proposal was technically evaluated and scored 36 out of 50. The PAC decided that the proposal may be shortlisted for submission of DPR / business case with the inclusion of other horticultural crops (vegetables) and detailing about Tissue Culture Lab.

14. M/s Privilege Advisory Services Private Limited (Consortium of Private Limited Companies) - Project Code, 18ACDP000103

The applicant M/s Privilege Advisory Services Private Limited is a Private Limited Company and has the application in consortium with M/s Baruah Automobiles Private Limited. The applicant has experience in the field of agri and allied sectors, including horticulture production, processing, aggregation and cluster-based value chain development. The applicant has implemented government-sponsored livelihood and horticulture development projects in Assam and the Northeastern Region. For FY 2023-24 the applicant's turnover is INR 8411.21 Lakhs and networth is INR 1221.79 Lakhs. The applicant has submitted a concept note to set up a Multi Commodity High Value Cluster with ghost pepper as focus crop in Assam.

The committee reviewed the concept note and observed that the applicant meets all legal and financial criteria, including equity, net worth and a clean financial declaration. The proposal was technically evaluated and scored 37 out of 50. The PAC decided that the proposal may be shortlisted for submission of DPR / business case.

The committee also briefly discussed other proposals that were non-shortlisted since they were found to not meet the eligibility, technical and financial criteria. The case wise decision of the PAC is presented in the table below:

Applications not shortlisted for submission of Business Case/ DPR:

The PAC discussed the following project proposals in details in the light of contents of agenda notes and scheme guidelines of CDP and decided that the proposals (sr. no. 1 to 37) may not be shortlisted due to non-compliance with eligibility criteria & responsiveness checks. The PAC committee members also observed that some of the applicants appears to be serious but lack a clear understanding of CDP programme. Therefore, the PAC members have discussed & consulted each other and decided that a ten-day window i.e. 04.09.2025 to 14/09/2025 till 6:00 PM may be given to correct the submitted concept notes. The PMU-CDP & NHB officials may assist the applicants (Sr. No. 1 to 37) in completing their concept notes.

The PAC committee also specified that the proposal listed at **Sr. No. 38 and 39** may be rejected, as their project proposal does not align with the objective of the scheme guidelines.

The PMU-CDP & NHB officials shall be available to provide any necessary guidance / clarifications to the applicants during the ten-day window daily between 3:00 PM to 5:00 PM till 14/09/2025.
