- 2. In the case of NHB, CDB, CIH, DCCD, DASD and other National Level Agencies under MIDH, the Central Assistance will be @ 100%. As per MIDH Guidelines, National Level TSG will be housed in NHB Gurgaon and the budget of National Level TSG (including National Bamboo Mission) shall be limited to 2.5% of BE including foreign travel component.
- 3. All the National level agencies (NLAs) implementing this scheme is requested to ensure that -
- (i) 16.6% of Plan Allocation be earmarked for Scheduled Castes farmers/beneficiaries under Scheduled Caste Sub Plan (SCSP),
- (ii) 8.6% of Plan Allocation be earmarked for Scheduled Tribes farmers/beneficiaries under Tribal Sub Plan.
- (iii) 30% of Plan Allocation be earmarked for Women beneficiaries/farmers. Efforts should be made to ensure gender equity in selecting beneficiaries.
- 4. Moreover, as per the Government Policy, Implementing Agencies shall be advised to accord priority to Persons with Disabilities (PWD) applicants in the implementation of the Scheme as per PWDs Act, 1995.
- 5. The grants shall be utilized and disbursed by the implementing agency in accordance with the procedures stipulated in the Department of Expenditure's OM No. 1(13)PFMS/FCD/2020 dated 23.03.2021 and as amended from time to time.
- 6. This issues with the approval of Secretary (DA & FW) vide Note# 190 of F. No. M-15012/1/2024-MIDH dated 22.04.2025.
