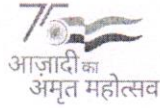

SBI, ADB Roorkee confirmed via letter dated 17.12.2024 that the earlier sanction is null and void . As the borrower changed bank branches and obtained a fresh loan without prior NHB intimation.
