

At the outset, Managing Director welcomed the members of the Internal Committee. Summary of discussions held and decisions taken by the IC are as under: -

#### **Confirmation of the Proceedings of the last IC Meeting held on 14.12.2016**

Proceedings of the last meeting of the IC held on 14.12.2016 were circulated to the members. There being no observation from any of the members, committee confirmed the minutes.

During the discussion in the meeting, it was observed that there is huge variation in the amount recommended by JIT and final EPC recommended by the concerned Division at HQ.

It was decided that Area Officer (s) may look into it and proposals may be placed in the Committee with full justification by JIT/Division at HO in respect of EPC and other issues. The proposals to be placed in State Committee should also be examined on same line.

The committee also discussed the budget allocation to each states and current status of utilization of budget under various categories. Committee felt that the budget utilization to Uttarakhand state has been very low as compared to its requirement and pendency. Several representations are being received for timely disbursement of subsidy to the hilly state.

In view of above, the Committee decided that in case of State of Uttarakhand project proposals inspected up to June, 2016 may be considered for grant of subsidy by utilizing the funds of the states such as Jharkhand and Bihar where no subsidy claim is pending and budget is also available.
